It is an honor to have the opportunity to let you know that I enthusiastically support your recommendation of Kurt Alme to the President for nomination to be the United States Attorney for the State of Montana. If Kurt is nominated, I certainly encourage you to also support his confirmation.

I have had the privilege of knowing Kurt for 20 years. In my opinion, his personal and professional integrity are beyond reproach. Kurt's professional resume is as impressive as they come. While Kurt's many academic accolades, Harvard Law degree, and prestigious Federal clerkship assured him a path to the riches of the Wall Street and Beltway firms, he instead returned to Montana to begin a legal career marked by service to Montanans.
