Dear Senator Daines and Senator Bennet,

The under-signed hunting and angling conservation, outdoor recreation, and scientific organizations extend our full support for your introduction of the Voluntary Public Access Improvement Act of 2017. Reauthorization of the Voluntary Public Access & Habitat Incentive Program (VPA-HIP) is a top Farm Bill priority for America's sportsmen and women, and we thank you for supporting this highly successful, state-led private lands access program.

VPA-HIP is the only program within the federal government designed to incentivize public recreational access on private lands. Since its reauthorization in the 2014 Farm Bill, wildlife agencies in 29 states and tribal lands have received \$40 million to expand public access and enhance wildlife habitat on more than 2.5 million acres. State wildlife agencies in Montana and Colorado have received \$1.2 million and \$1.5 million, respectively, to expand and improve their existing public access programs.

This legislation reauthorizes VPA-HIP at \$150 million over five years, a level reflecting the overall demand from state wildlife agencies as well as the economic benefits of the program. A recent study from the first year of program funding found an estimated 99 percent return on taxpayer investment through increased consumer spending. This spending directly supports thousands of jobs in the \$887 billion outdoor recreation economy, which helps catalyze rural economies nationwide.

We thank you for supporting this important priority for sportsmen and women across the country, and we look forward to working with you to ensure successful inclusion of this legislation in the next Farm Bill.
